## **New Clauses/Sub-clauses**

#### 1) Limitation of Liability

Except in cases of gross negligence or wilful misconduct: -

- a) Neither party shall be liable to the other party for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier/ selected bidder to pay liquidated damages to the Purchaser; and
- b) Maximum liability of the bidder for this project will be limited to the total value of the contract or the amount actually paid to the bidder whichever is lower and will not include any indirect or consequential clause or damage, loss or profit, data or revenue.

#### 2) Copyright/Intellectual Property Rights [IPR]

The copyright / Intellectual Property Rights in all drawings, source code, design documents, and other materials containing data and information furnished to the Purchaser that has been developed / customized by the Selected Bidder for the project herein shall remain vested in the Purchaser.

#### 3) Additional points under the clause no. 7 [Vol-II, Pg#69]

- a) Penalty for delay in deliverables would be maximum of 10% of Total Contract Value excluding Tax, after which OCAC shall be at liberty to cancel the contract.
- b) Penalty will not be applicable if the delay is not attributable to the bidder. However, in such cases bidder must communicate in writing the reason of delay. Decision of Chairman, OCAC in this matter is final.
