 have to be allocated shared / exclusive spaces for display of their products & services
- An exclusive meeting room and spaces for discussion with visitors, dignitaries, prospective collaborators, clients etc. may be provided
- A Reception desk to be properly positioned and the Facia of the Stall to be prominently displayed with lighting etc. besides adequate lighting of the stall
- · Potted decorative and/or flowering plants should be suitably placed in the pavilion
- The overall ambience and aesthetics should be of international standard in view of participation of prospective collaborators / clients from other countries in Indiasoft 2024
- Any other requirement that may be indicated by the undersigned for improvement of the overall ambience of the pavilion
